

PHONES

Dial "9" for an outside number. For internal calls, dial the last four numbers only.

Emergency (Police, Fire, and Medical):

DIAL "9-911" and contact Security Office at x8059.

BREAK ROOMS

Break rooms are located throughout the facility at each end of the floor off the main corridors and typically contain coffee brewing equipment, refrigerator/freezer and a microwave oven.

Vending machines are located in the first floor break room 1613, providing a variety of salads, sandwiches, chips, drinks and other snacks.

SMOKING POLICY

SECURITY & CHECK-IN

The Security Department is located on the first floor, 1645B. The Security Desk is located in the lobby on the right side after you enter the front doors.

You must provide a photo ID when you arrive. The check-in process takes approximately 15 minutes, so please plan accordingly.

In compliance with Northrop Grumman Corporate Policy and Procedure J109, Northrop Grumman reserves the right to inspect all persons, vehicles, hand-carried packages and containers prior to allowing entry into non-public areas of its facilities, again at departure from the facility, and at any time while on company premises.

In compliance with Northrop Grumman Corporate Policy and Procedure J109, the following items are prohibited in company facilities except when officially required for the performance of a contract:

- Weapons and ammunition of all types except for law enforcement, military, or authorized security personnel
- Explosive and incendiary devices except those associated with or necessary for contractual work on military or similar articles
- Alcoholic beverages
- Illegal drugs and other controlled substances not legally authorized for the holder.

In compliance with Northrop Grumman Corporate Policy and Procedure J109, introduction and use of the following categories of personal and company property items by employees and visitors is restricted on company premises, and these items must not be used in any manner that violates security limitations described in the referenced policy.

The use of these items is restricted and each item must be declared at the Security Desk before bringing into non-public areas:

- Personal cameras, including still and video, digital and film
- Cell phones – all features
- Personal laptop computers, palmtop computers and personal digital assistants (PDAs) such as Blackberry devices
- Electronic and optical recordable media of all types (including thumb/flash drives)
- Sound recording devices of all types

DIRECTIONS

The Global Combat Service System – Army (GCSS-Army) project is located in the Northrop Grumman / Patriot Tower Building. Just off Midlothian Turnpike at the Powhite Parkway interchange, the building is behind and across from Bob Evans Restaurant. After you turn off Midlothian Turnpike, take the first right into the parking circle.

Directions from the South:

Take I-95N to Chippenham Parkway (VA-150) North to Midlothian Turnpike (US 60W), go 1.9 miles then turn right onto Gateway Centre Parkway. The Northrop Grumman building will be on your right.

Directions from the North:


Take I-95S to Chippenham Parkway (VA-150) North to Midlothian Turnpike (US 60W), go 1.9 miles then turn right onto Gateway Centre Parkway. The Northrop Grumman building will be on your right.

Directions from the East (RIC Airport):

Take I-64W to I-95. At exit 190, take ramp left for I-95 South / Richmond-Petersburg Turnpike toward Petersburg. At exit 74A, take ramp right for I-195 North / SR-195 West toward Powhite Pkwy. Keep left onto SR-146 South / Powhite Pkwy. Keep straight onto SR-76 South / Powhite Pkwy and then keep left for SR-76 South / Powhite Pkwy. Take ramp right for US-60 East / Midlothian Turnpike toward Richmond. Turn left onto Gateway Centre Parkway in .1 miles. The Northrop Grumman building will be on your right.

Directions from the West:

Take I-64E to 288 South. Take 288 South to SR 60 East /Midlothian Turnpike. Turn left onto Gateway Centre Parkway. The Northrop Grumman building will be on your right.



PARKING

Handicap and Visitor parking is directly in front of the building, and marked accordingly. There is additional parking on each level of the two-story parking deck. Overflow parking is located across the street on the east side of the parking deck.
